■ RCR Community in Taiwan



Before 2009 Had almost nothing

- ▶ No clear research integrity policies and mandates of RCR training
- ▶ People unknowingly engaged in questionable practices



In 2009 A group of senior researchers: “do something”

- ▶ Hope: fix existing problems; reform research cultures to be more **responsible & transparent**
- ▶ Tasks: translated a book of ORI, recruited people (built a network of like-minded), and sought supports from government units



Since 2009 – present A new and small group is there.

- ▶ Goals: change culture, meet global trends, and gain public trust

■ The Golden Triangle Approach



National: Support Taiwan's government (MOE & MOST) to promote RI and RCR (e.g., making policies, briefing announcements of new law/policies to the public, facilitating case investigation as needed)



Institutional: Help and oversee Taiwan research units (universities and institutions) establish mechanisms of (a) managing RI & research misconduct and (b) implementing institutional RCR training



Individual: Help local researchers practice RCR in their day-to-day professional activities through online and face-to-face RCR training and consulting

More than **51,000,000** visits in 2019.

258 (85%) universities and research institutions require **ALL** of their faculty, researchers, or grad students across all fields to take RCR training.




Achievement of the First Decade

2012 – 2016: Institution readiness to engage in RCR





How to sustain and advance the effectiveness of RCR education?

■ Sustainable Implementation of RCR Education

Customize Education to be More Culturally Relevant & Inclusive

- ▶ The concept of RCR was conceptualized in response to historical events in **Western** society in scientific research.
- ▶ We found some unsolved issues caused by differences (even conflicts) between Eastern and Western cultures.
- ▶ Example: Western RCR norms about navigating “relationships” are actually very limited in their effectiveness in East Asian societies.

■ How to Decide Authorship?



In RCR Education

- Depends on each individual's contribution
- Decision collectively made by all team members
- Follow international guidelines (e.g., ICMJE)



In the Reality (East Asia)

- Made solely by the PIs (lack of transparency?)
- During the decision-making, social hierarchy and power relations override individual intellectual contributions.
- Sometimes it looks disrespectful and offensive when a junior student makes a request to negotiate senior faculty members' authorship decisions.



Updated: Lax reviewing practice prompts 60 retractions at SAGE journal

The academic publishing industry has been rocked by scandals in recent years, **most of them uncovered by outsiders**. But the latest comes from an internal probe: A 14-month investigation by the publisher SAGE has uncovered a fake peer-review scam involving hundreds of fraudulent and assumed identities. **A total of 60 research articles published over the past 4 years in the *Journal of Vibration and Control* (JVC) are being retracted.** SAGE concludes that the scam was orchestrated—possibly alone—by one physicist, Peter Chen, at the National Pingtung

Education minister resigns over research fraud scandal

Taiwan's Education Minister Chiang Wei-ling resigned on Monday 14 July over his links to a researcher whose papers were retracted from an international scientific journal because of alleged fraud.

The minister has said he will return to teaching at National Central University in Jongli in northern Taiwan. He was president of the university before joining the cabinet in February 2012, the state-run news agency CNA reported.

Sun Lib-chyun, spokesperson for the Executive Yuan – roughly equivalent to Taiwan's cabinet – confirmed that the minister's resignation had been accepted by Premier Jiang Yi-huah, and that Deputy Minister Chen Der-hwa would assume the role of acting education minister until a successor was formally announced.

Chiang said in a statement that the decision to resign was made to uphold his own reputation and avoid unnecessary disturbance of the work of the education ministry, after the incident ignited a wave of

■ Why they take risks to engage in unethical authorship?

Satisfy traditional values of ethics used to handle mentor-mentee relationship:
maintain social harmony, obey hierarchy & power relation, respect for authority

“ PhD Students

‘do favors (offer “renqin [人情]”) for influential figures in academia’
‘show some respect and gratitude to other researchers, such as advisors’

“ Research Fellows (faculty, postdocs)

‘consolidate their professional standing and influence in administrative affairs’
‘consolidate their collaborative ties with other researchers and teams’
‘gain more opportunities to perform academic services, such as serving as an editor for journals or the chairman of conferences’

■ Customize RCR Education

Identify Something that Doesn't Work and Fix It

- ▶ Do more cultural research to understand how cultural habits and traditional values affect researchers' day-to-day practices
- ▶ Pursue international collaborations to learn the differences in professional-decision making in science between East Asian and Western people.
 - ▶ e.g., NSF grant proposal: *Advancing the use of professional decision-making strategies in a culturally diverse research community*

Customize Current RCR Training Content


- ▶ Make it more consistent with the research context that Taiwanese researchers experience
